

Boulder Yacht Club General Meeting and Election Minutes 8 October 2006

The meeting was held at the Boulder Marina Club Lounge, Carlyle Lake. Bill Schmidt, BYC Commodore opened the meeting at 9:30 am. Art Seise, BYC Board Chairman reviewed the ballot and explained the proposed BYC By- Law changes to be voted on during the election.

The boat slip requirement addition to the By-Laws for club officers was questioned from the floor. The board members present explained the change was to ensure that officers would be active BYC club members with the best interest of the club in mind. Without this change, it could be possible for control of BYC to fall into hands of a group with a conflict in interest to the BYC membership and/or charter. Some members felt the new restriction could eliminate some good members, who don't rent slips from becoming officers. Also, it was pointed that this excludes members that own boats, stored on the "hard" or at home.

The current BYC financial status was reviewed. The clubs financial status is good with a net income of \$4,322.76. Someone asked if this included the \$1,000.00 reserve fund set up to take care of upkeep and repair of the tent. It does not. The "tent" fund is still available plus a few dollars of accrued interest.

Ballots were handed out, it was stated that there is only one vote per membership unit. A copy of the ballot is attached to these minutes for the record. The ballots were collected, and Art Seise provided absentee ballots he received in the mail. All absentee ballot were properly notarized as required by the By-Laws. Ken Schowe and Dave Commens went to the Marina Office to count the votes. The result of the election of officers and the By-Law changes are as follows:

General Meeting Business

Art Seise contacted the tent company about buying the BYC tent since we no longer need it with the pavilion. However, they are not interested. So for now the club will keep the tent. Bill Schmidt suggested we look into using part of the tent to make a cover for to be attached to the pavilion when bands or other groups perform at BYC. A motion was made from the floor to investigate using the tent as a band stand cover, it was approved and seconded.

Bill Schmidt thanked Kort and Laurel Juenger for hosting the Chili Supper, and Erik Eaves for setting up and coordinating the Commodore's Cup.

Gary Lopez discussed No Boat Party format changes. The location has not been set up yet, and at the meeting a motion was made to establish the last Saturday 24 February 2007 as the date for the No Boat. The motion was approved and seconded at the meeting

The meeting adjourned about 10:30 am.

PROPOSED BY LAW CHANGES

First By-law revisions requiring Directors and Flag Officers to be members of households leasing a slip at Boulder Marina:

ARTICLE IV - BOARD OF DIRECTORS, SECTION A, is revised as follows:

The Board of Directors shall consist of five (5)Directors. A Director shall be a member of a household unit leasing a slip at Boulder Marina for the complete term of office. Two of the Directors shall be the two most recent Past Commodores. The remaining three (3)Directors shall be elected at large from the members. To be qualified to hold the position of a Director-at-Large, the member must have been a member of Boulder Yacht Club for the last three (3) consecutive years. Initially, only two (2) Directors will be elected from the members at large with three Directors being the three most recent Past Commodores. One Director shall serve for two (2) years and one Director shall serve for one (1) year. Thereafter, on the next year, two(2) Directors will be elected to serve, one for three (3) years and one for one (1) year. The following year and every year thereafter, one Director will be elected at large for a three (3) year term.

and

SECTION E:

The Board of Directors shall have the power to remove any Director or elected officer by majority vote of the Directors, excluding the Director(s) subject to removal. Prior to holding an election to remove a Director or Elected Officer, the other Directors must give the Director or Elected Officer to be removed at least fifteen (15) days written notice of the meeting before it is called for that purpose. A Director or elected officer may only be removed for failing to perform his duties as a Director or Elected Officer for the following reasons: By not attending meetings; by failing to give his or her time and interest in the operation and management of the Club; by failing to maintain the lease of a slip at Boulder Marina or, in the case of Elected Officers, failing to perform the duties prescribed in Articles V or VI, as appropriate.

and

ARTICLE V - OFFICERS, SECTION A, is revised as follows:

The elected officers of the Club shall be designated Commodore, Vice-Commodore, Secretary/Treasurer, Race Chairperson and Social Chairpersons(s). These Officers shall be Flag Officers. A Flag Officer shall be a member of a household unit leasing a slip at Boulder Marina for the complete term of office. The Vice-Commodore, Secretary/Treasurer, Race Chairperson and Social Chairperson shall collectively be called the Staff Officers hereinafter. The Commodore and Vice-Commodore shall only serve one (1) consecutive year. The Secretary/Treasurer and Social Chairperson may not serve more than two (2) consecutive years. The Race Chairperson shall be elected to a two (2) year term of office, the first year of the term being served as Race Chair and the second year of the term being served as Race Chair Advisor. A Race Chairperson shall be elected every year so as to create continuity in the program with the overlapping of terms. To be qualified to hold the position of an elected Officer, with the exception of the Social Chairperson, the member must have been a member in good standing of Boulder Yacht Club for the last two (2) consecutive years prior to the date that member would assume office. The Social Chairperson must have been a member in good standing of Boulder Yacht Club for the year prior to the date that member would assume office.

Second By-law revision to require an amendment to the By-laws to change the dues and to increase the annual dues to \$35.00:

ARTICLE X - DUES, SECTION A - DUES is revised as follows:

Dues for members may be increased or decreased by an amendment to these By-laws in accordance with ARTICLE XI. Dues shall be due and paid on or before March 1^{st} of each year, and if not paid by then, shall be considered delinquent. Annual dues are fixed at \$35.00 per household unit.
